ALL that piece, parcel or lot of land with all buildings and improvements, situate, lying and being on the eastern side of Wilton Street in the City of Greenville, Greenville County, South Carolina being shown as Lot No. 27 on a plat of the property of David Kohn, et. al., prepared by W.
