Reconstructing Old Airport Road (Woods Crossing Road) to a three lane facility with curb and gutter beginning at Haywood Road and ending at the Haywood Mall Connector Road.

Together with the right of ingress and egress for the purpose of inspecting and maintaining the same.

Said property is described as follows: Located in the City of Greenville along existing Old Airport Road (Woods Crossing Road) and being all of Area A as shown on attached survey and being more particularly described as follows:
