in consideration of Eleven Thousand Five Hundred and NO/100--- (\$11,500.00)----- Dollars,

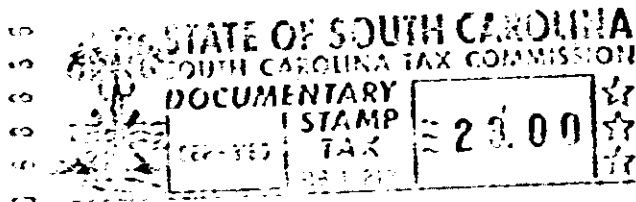
