the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Linda Faye Taylor (formerly Linda S. Nalley) her heirs and assigns, forever:

All my one-half right, title and interest in and to all that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of the Easley Bridge Road shown as Lot 12 on Map 2 of Camilla Park of the John D. Marshall Estate, a plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book M at Page 85 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeastern side of Easley Bridge Road, which iron pin is 160 feet in a southwesterly direction from Harvard Avenue, at the joint corner of Lots 11 and 12 and running thence along the joint line of said lots, S 60-51 E 205 feet to an iron pin at the joint rear corner of said lots; thence along the rear joint line of Lots 12 and 56, S 27-40 W, 80.7 feet to an iron pin at the joint rear corner of Lots 12 and 13; thence along the joint line of said lots, N 60-51 W 207.6 feet to an iron pin in the line of Easley Bridge Road; thence along the southeastern side of Easley Bridge Road, N 29-09 E 80 feet to the point of beginning.
