release unto Hayward M. Thompson, Jr. and Rosa T. Thompson, their heirs and assigns, forever

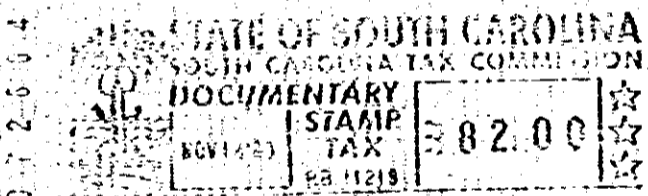
ALL that certain piece, parcel or unit, situate, lying and being
