"PREMISES"

THENCE, S 47° 03' E, continuing along the line of property of Bertie M. Burns a distance of 70.04' to an old iron pin;

THENCE, S 61° 05' E, continuing along the line of property of Bertie M. Burns a distance of 170.45' to an old iron pin;

THENCE, S 77° 16' E, continuing along the line of property of Bertie M. Burns a distance of 106.63' to an old iron pin;

THENCE, S 70° 31' E, continuing along the line of property of Bertie M. Burns a distance of 87.61' to an old iron pin;

THENCE, S 57° 33' E, continuing along the line of property of Bertie M. Burns a distance of 204.09' to an old iron pin;

THENCE, S 35° 43' W, continuing along the line of property of Bertie M. Burns a distance of 301.60' to a poplar tree;

THENCE, S 20° 17' E, continuing along the line of property of Bertie M. Burns a distance of 242.98' to an old iron pin, said pin being the corner of property of Bertie M. Burns and on line of property now or formerly of Irene J. and Joseph J. Thurston;

THENCE, S 44° 12' W, along the Thurston line a distance of 303.29', to an old iron pin, said pin being the joint corner of property now or formerly owned by Thurston and Acme Realty Company;

THENCE, S 44° 09' W, along line of Acme Realty Company a distance of 491.19' to an old iron pin, being the joint corner of property now or formerly owned by Acme Realty Company and T.M.F. Company;

THENCE, N 45° 41' W, along T.M.F. Company line a distance of 211.67' to an old iron pin, the joint corner of property now or formerly owned by T.M.F. Company and Sun Vent Awning, Inc.;

THENCE, N 25° 54' W, along line of Sun Vent Awning, Inc. a distance of 242.04' to an old iron pin;

THENCE, S 41° 50' W, along line of Sun Vent Awning, Inc. a distance of 109.22' to an old iron pin;

THENCE, S 25° 42' E, along line of Sun Vent Awning, Inc. a distance of 129.11' to an old iron pin;

THENCE, S 44° 56' W, continuing along line of Sun Vent Awning, Inc., a distance of 423.82' to a new iron pin at the southwest corner of Sun Vent Awning, Inc., on the northeast line of right-of-way of Highway Interstate 385 (I-385);

THENCE, N 46° 44' W, along the northeast line of right-of-way of I-385 a distance of 00.83' to a new iron pin;

THENCE, N 46° 22' W, continuing along northeast line of right-of-way of I-385 a distance of 195.68' to a concrete monument;

THENCE, N 46° 21' W, continuing along northeast line of right-of-way of I-385 a distance of 204.66' to a concrete monument;
