To All Whom These Presents Shall Come:

I, FRANK P. McGOWAN, JR., as Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Loyd A. Smith

on or about the 7th day of January in the year of our Lord nineteen hundred and eighty exhibited his

complaint in the Court of Common Pleas for the County aforesaid, against Georgia S. Hudson, Sue S. McCall, Kay S. Siau, Ruby McCall Walker, Ronnie Ray McCall, Harvey William Hudson, Jr., a minor over the age of fourteen (14) years, Timothy Mark McCall, a minor under the age of fourteen (14) years, Georgia S. Hudson as representative of unborn children of Loyd A. Smith and Ronnie Ray McCall as representative of unborn grandchildren of Loyd A. Smith, demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard

on the 26th day of March 1980,

ALL that certain piece, parcel or tract of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, and being shown on plat entitled "Loyd A. Smith Life Estate, Tract 2" as prepared by Freeland & Associates dated October 24, 1979 as recorded in the RMC Office for Greenville County, South Carolina in Flat Book 73, Page 74, and having according to said plat the following notes and bounds to-wit:
