ALL water lines, mains, valves and appurtenances installed and located in or along Harrisburg Drive, Appomattox Drive, Gettysburg, Powderhorn Road and Rapidan Court, County of Greenville, State of South Carolina including approximately 1630 feet, more or less of 8" D. I. Pipe; 40 feet, more or less of 6" D. I. Pipe; 1280 feet, more or less of 2" Galv. Pipe; 3 6" Valves; 9 2" Valves and 3 Fire Hydrants and is shown on a drawing entitled "American Service Corporation of South Carolina to Commissioners of Public Works of the City of Greenville, S.C." dated April 6, 1981, attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to the said lines and all right-of-way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.
