1,020 feet, more or less of 2" Galv. Pipe; 1 8" Valve; 9 6" Valves; 4 2"
Valves; and 5 Fire Hydrants, and is shown on a drawing entitled "U. F. S.
Service Corporation to Commissioners of Public Works of the City of Green-
ville, S.C." dated April 21, 1981, attached hereto and made a part of this
