I, FRANK P. McGOWAN, JR., as Master in and for the County aforesaid, SEND GREETING:

our Lord nineteen hundred and seventy-seven exhibited their  
complaint in the Court of Common Pleas for the County aforesaid, against  
H. W. Moon, Doris Stones Moon, Claude Moon, Hugh Jackson Moon and  
Betty Moon

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard  
on the 3rd day of July 19 79  
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and

for the County of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto  
the said H. W. Moon and Hugh Jackson Moon:

ALL the right, title and interest of H. A. Moon in and to the following  
described property:

ALL that lot of land in the State of South Carolina, County of Greenville,  
in Dunklin Township, consisting of such portions of lots 2, 3, 8 and 8.1  
of Block 1 of Sheet 598.2 of the Greenville County Tax Maps as shall lie  
on the northwesterly side of the center line of a county road known as  
Epps Road.

The aforesaid property was the subject of a Court action entitled H. A.  
Moon and Eunice Moon vs. H. W. Moon, et al, which action was terminated  
by an Order of the Circuit Court dated June 13, 1978, all of which will  
appear by reference to the Judgment Roll in such action and this conveyance
