THIS WARRANTY DEED, made this 14th day of July, 19 81, between Gerald Pressley of Orange County, State of Florida, Grantor(s); and James E. Ely and Sarah H. Ely of Greenville County, State of South Carolina, Grantee(s);

WITNESSETH: That the said grantor(s) for and in consideration of the sum of One Thousand Nine Hundred Ninety and no/100 Dollars (\$1,990.00), to me in hand paid by the Grantee(s), the receipt whereof is hereby acknowledged, has

granted, bargained, sold and conveyed and by these presents do grant, bargain, sell and convey unto the said Grantee(s) for and during their joint lives and upon the death of either of them, then to the survivor of them, his or her heirs and assigns forever in fee simple, together with every contingent remainder and right of reversion, the following described land, lying and being in the County of Greenville

State of South Carolina, to-wit:

All of my undivided right, title, and interest in and to all of that certain piece, parcel or tract of land, situate, lying and being in the County of Greenville, State of South Carolina, and according to a survey prepared by T. H. Walker, Jr., R.L.S., May 4, 1981, and which said plat is recorded in the R.M.C.
