Bryan, his heirs and assigns forever;

ALL that certain piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, on the eastern side of Batesville Court, being shown and designated as Tract No. 3 on a plat entitled "Property of T. Walter Brashier", dated April 24, 1979, and revised September, 1979, said plat being recorded in the RMC Office for Greenville County in Plat Book 80 at Page 100, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point 262 feet from the intersection of Batesville Court and Batesville Road and running thence with the right-of-way of Batesville Court, N.25-54 E. 24.7 feet to an iron pin; thence continuing with said right-of-way, N.25-43 E. 279.1 feet to an iron pin; thence turning and running S.64-46 E. 392.2 feet to an iron pin; thence turning and running S.31-13 W. 353.3 feet to an iron pin; thence turning and running N.64-46 W. 257.1 feet to an iron pin; thence turning and running N.39-49 W. 113.2 feet to the point of beginning.

THIS conveyance is subject to all restrictions, setback lines, roadways, zoning ordinances, easements and rights-of-way appearing on the property and/or of record.
