 unto Jack C. Stewart and Nancy M. Stewart, their heirs and assigns, forever;

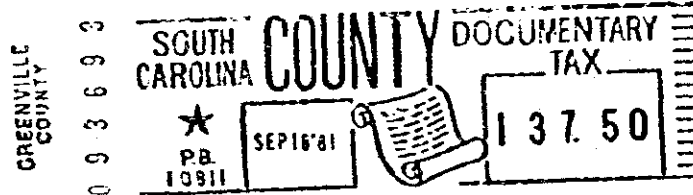
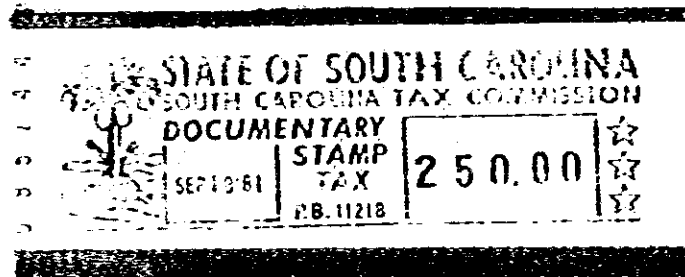
