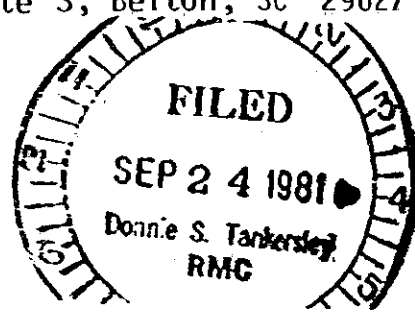

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Tony C. Coker & Susan Lynn Coker; their heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, containing 6.2 acres, more or less, as shown on plat prepared by James L. Strickland, Surveyor, dated July 1981, entitled "Survey for Tony Coker", recorded in Plat Book 8-61 at Page 62 of the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint corner of this tract and other property of Tony Coker as shown on the above referred to plat, said iron pin being 390.4 feet, more or less, from the center line of Lickville Road; thence running, N 63-55 W 310.6 feet to an iron pin and continuing N 63-55 W 42.2 feet to an iron pin; thence turning and running, N 27-32 E 808.7 feet to an iron pin in creek; thence following the center of the creek of the creek as the line the following approximate courses and distances: S 60-44 E 43.4 feet, S 63-02 E 86.0 feet, N 47-54 E 54.6 feet, S 82-44 E 142.2 feet to a Black Gum stump at fence; thence turning and running with line of property now or formerly of Cecil Holliday, S 23-01 W 903.3 feet to the point of beginning.
