the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William E. Patterson, his heirs and assigns forever,

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as a portion of Lot 2 as shown on plat prepared by R. E. Dalton dated June 26, 1916, recorded in the RMC Office for Greenville County in Plat Book BB at page 38 and being more particularly described as follows:

BEGINNING at an iron pin on the southern side of S. C. Highway No. 416 at the joint front corner of Lots 2 and 3 and running thence along the joint line of said lots, S. 45-03 W. 151.8 feet to the northern side of Old Cedar Lane Road; thence along approximately the same course to the center of Old Cedar Lane Road; thence running in a southeasterly direction and following the curvature of the center line of said Road a distance of 94 feet, more or less, to a point in the center of said Road; thence N. 45-03 E. 25 feet, more or less, to an iron pin on the northern side of Old Cedar Lane Road; thence along the joint line of Lots 1 and 2, N. 44-41 E. 116.7 feet to an iron pin on the southern side of S. C. Highway 416; thence N. 44-57 W. 80.5 feet to the point of beginning.

This conveyance is made subject to rights-of-way, easements and protective covenants of record and particularly the right-of-way of the S. C. Highway Department.
