ALL that certain piece, parcel, and lot of land, lying and being on the westerly side of Cox Street, near the City of Greenville, in the County and State aforesaid, and having, according to a plat prepared by H. C. Clarkson, Jr., Campbell & Clarkson Surveyors, Inc., dated March 22, 1974, the following metes and bounds:

BEGINNING at an iron pin on the westerly edge of the sidewalk on the westerly side of Cox Street, said pin being located 307 feet, more or less, north of the northwesterly corner of the intersection of Johnson Street and Cox Street, on the southerly edge of Wilkie Street, also known as Willow Alley, and running thence along the westerly side of Cox Street S. 1-35 W. 87 feet to an iron pin at the joint front corner of land of Grantor and land now or formerly owned by Jeter; running thence along the common line of Grantor's property and that of Jeter, S. 89-30 W. 167.4 feet to an iron pin at the joint rear corner of Grantor's property and that of Jeter; running thence N. 13-13 E., 90.6 feet to an iron pin on the southerly side of Wilkie Street; running thence along the southerly side of Wilkie Street, N. 89-55 E. 149.5 feet to the point of beginning.
