the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto

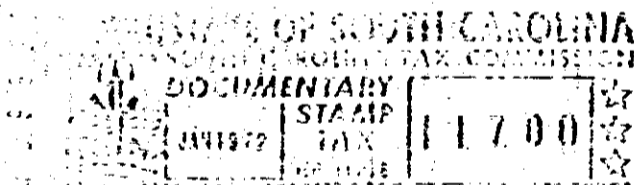
A. C. COBB, JR. (a/k/a A. Courtney Cobb, Jr.), his heirs and assigns, forever:
