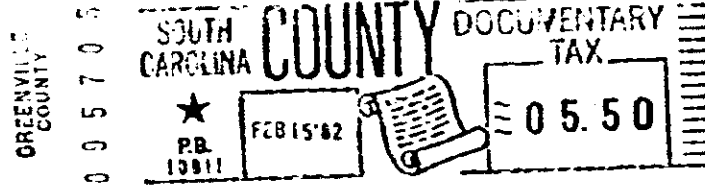
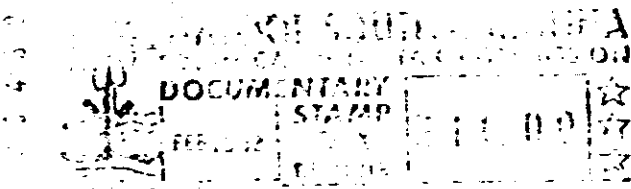
KNOW ALL MEN BY THESE PRESENTS, that JOHN WALTER EGAN, III, and DONNA B. EGAN,
