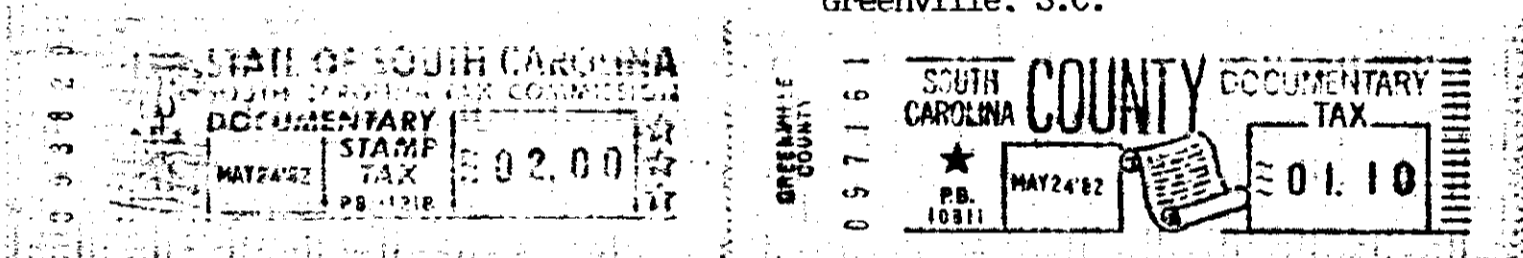

It is distinctly understood that said lots are to be used exclusively for the burial of human bodies and are sold and conveyed subject to all rules and regulations and any additions or amendments for the government of the cemetery.

This conveyance is made subject to any restrictions, easements, rights of way, zoning ordinances and roadways appearing on the property and/or of record.

This being the same property conveyed to Grantors by deed of Christ Church Endowment Corporation recorded in the RMC Office for Greenville County in Deed Book 873 at page 327 on August 7, 1969.
