KNOW ALL MEN BY THESE PRESENTS, that Suinual, Inc.

A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of One (\$1.00) Dollar and the correction of certain distances in prior deed Dollars,

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto John Clayton Haney and Vivian S. Haney, their heirs and assigns:

ALL that certain piece, parcel or tract of land located in Greenville County, South Carolina, being known as Tract 2 on a plat of Debbie Hights prepared by T. H. Walker, Jr., registered land surveyor, on December 12, 1979, being more particularly described as follows:

BEGINNING at a point in the center of Speedway Drive, said beginning point being approximately 292.61 feet northwest of the center of the intersection of said Speedway Drive with Fountain Inn Drive, said beginning point being the joint front corner of Tracts 2 and 3 on said plat and running thence along the center of Speedway Drive N 60-08 W 225 feet to a point in the center of Speedway Drive, the joint front corner of Tracts 1 and 2 on said plat; thence turning and running along the joint line of Tracts 1 and 2 on said plat S 53-34 W 520.21 feet to a point joint rear corner of Tracts 1 and 2; thence turning and running along the joint line of Tract 2 and 6 on said plat S 53-19 E 200 feet more or less to a point the joint rear corner of Tracts 2 and 3 on said plat; thence turning and running along the joint line of Tracts 2 and 3 N 55-05 E 552.76 feet more or less to the point of BEGINNING.

This being a portion of the property conveyed to the Grantor herein by deed of Melvin R. Launius on the 25th day of September, 1980, said deed being recorded in the Greenville County RMC Office in Deed Book 1136 at Page 203.

The purpose of this deed is to correct the description given in an earlier deed by this Grantor to this Grantee, said deed recorded in the Greenville County RMC Office on March 1, 1982 in Deed Book 1163, at Page 106. The description above is the true and accurate description of the property intended to be conveyed by the Grantor to the Grantees.
