

2. WE RESERVE TO OURSELVES the power and right to collect any rental or other income which may accrue from the trust property and in our sole discretion as Trustee(s), either to accumulate such income as an addition to the trust assets being held hereunder or to pay such income to ourselves as an individual(s).

3. WE RESERVE UNTO OURSELVES the power and right at any time during our lifetime to amend or revoke in whole or in part the trust hereby created without the necessity of obtaining the consent of the beneficiaries and without giving notice to the beneficiaries. The sale or other disposition by us of the whole or any part of the property held hereunder shall constitute as to such whole or part a revocation of such trust.

4. THE DEATH DURING our LIFETIME, or in a common accident or disaster with us, of all the beneficiaries designated hereunder shall revoke such designation, and in the former event, we reserve the right to designate such new beneficiary as we deem proper. Should we for any reason fail to designate such new beneficiary, this trust shall terminate upon our death and the trust property shall revert to our estate.

5. AS USED HEREIN the terms we, us, our, ourselves etc. are intended to include the survivor Trustee.

6. IN THE EVENT OF our DEATH OR LEGAL INCAPACITY, we hereby nominate and appoint as Successor Trustee hereunder Brooks C. Preacher, Jr. and upon his or her failing or ceasing to act, then we nominate and appoint Stephen P Preacher of San Diego County ADDRESS: California, 2931 Segovia Way Rancho La Costa 92008 as Successor Trustee, and upon his or her failure or ceasing to act OR SHOULD we FOR ANY REASON fail to designate the person above intended to be nominated, then we nominate and appoint as Successor Trustee hereunder whosoever shall qualify as executor, administrator or guardian, as the case may be, of our estate.

7. THIS DECLARATION OF TRUST shall extend to and be binding upon the heirs, executors, administrators and assigns of the undersigned and upon the Successors to the Trustee(s).

8. THE TRUSTEE(S) AND their SUCCESSORS SHALL SERVE WITHOUT BOND.

9. THIS DECLARATION OF TRUST shall be construed and enforced in accordance with the laws of the state of South Carolina.
