All that piece, parcel or lot of land located in the County of Greenville, State of South Carolina, situate, lying and being on the northern side of Paris Mountain Avenue and being known and designated as Lot No. 61 as shown on plat of Subdivision of Perry Property recorded in the RMC Office for Greenville County in plat book 0 at page 45, and having according to said plat the following metes and bounds, to-wit:
