in consideration of Nine Hundred (\$900.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

JAMES L. TROTTER, his heirs and assigns forever:

ALL that piece, parcel or lot of land in the State of South Carolina, County of Greenville being known and designated as LOT NO. 57 of a subdivision known as Holly Vista as shown on a plat thereof, dated February 1956, recorded in the R.M.C. Office for Greenville County in Plat Book BB page 191 and having according to said plat the following description, to-wit:

BEGINNING at an iron pin on Woodbriar Road at joint front corners of Lots 56 and 57 and running thence 50 feet, more or less, with the line of said Road to an iron pin at joint front corners of lots 57 and 58; running thence 163 feet, more or less, with the side line of lot 58 to an iron pin at joint rear corners of lots 57 and 58 and side corner of lot 60; running thence 50 feet, more or less along the side line of lot 60 to an iron pin at joint corners of lots 57, 56 and 60; running thence 163 feet, more or less, with the side line of lot 56 to the iron pin at joint corners of lots 56 and 57 on Woodbriar Road, the point of beginning.

No residence to cost less than \$7,500.00 shall be erected on said lots; no residence shall be erected on any lot unless said lot has 50 feet, or more, frontage; no residence shall be built on any lot nearer than 30 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

This deed is made subject to all easements and rights of way of record.

Grantee shall be responsible for the 1983 taxes.

This conveyance is the property conveyed to Mrs. M.T. Boykin by deed of M. W. fore on June 18, 1966 and recorded in Deed Book 800 at page 442 on June 20, 1966 in the R.M.C. Office for Greenville County.
