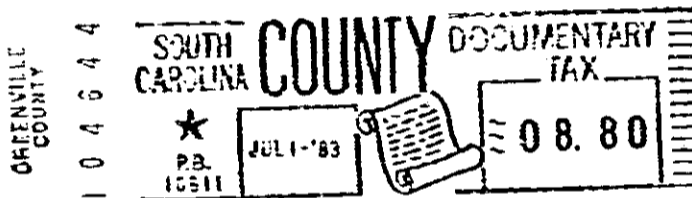
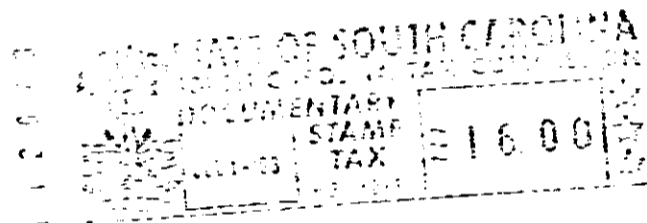
CHARLES E. CHAMBLEE, his heirs and assigns forever:
