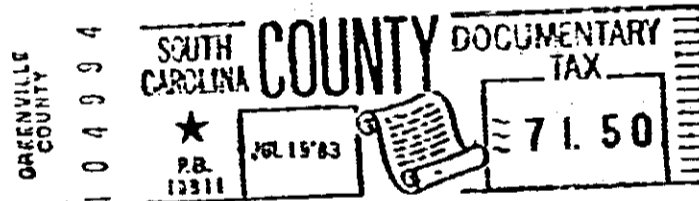
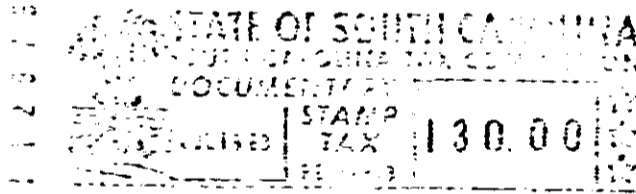
V. W. Jernigan, his heirs and assigns, forever:
