the Grantor as shown on the drawing entitled "Orchard Park Apts., Phase I to
Commissioners of Public Works of the City of Greenville, S.C.", dated July 14,
1983, attached hereto and made a part hereof for the purpose of reading,
operating, maintaining, replacing and adding to the water meters and other
appurtenances thereto located on the property of the Grantor.

IT BEING understood that the water mains located in and serving Orchard Park
Apartments, Phase I, and being on the property of the Grantor shall and do
remain the property of the Grantor and the Grantor shall be fully responsible
for the maintenance thereof.
