PARCEL THREE: All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina.

BEGINNING at a point in the center of the Augusta Road about three miles south of the City of Greenville, S.C., and about 600 feet from the intersection of the Fork Shoals Road, at the corner of a lot conveyed to E. Lucinda Derden, and running thence with her line in a westerly direction, approximately 574 feet to line of lot formerly owned by E. F. Woodside, thence with the line of said property N. 6-52 E. 9.6 feet to stake; thence N. 3.00 E. 60.4 feet to lot now or formerly of Elizabeth E. Voyles; thence with her line in an easterly direction 559.8 feet to point in the center of the Augusta Road; thence with the center of the road, S. 2-05 E. 100 feet to the beginning, being known as part of Lot #14 on plat of Piedmont Corporation made by W. J. Riddle, July, 1934.

BEGINNING at a stake on the Southern side of Woodmont Circle, 130 feet West from Augusta Road at corner of Lot No. 3, and running thence with the Southern side of said Circle, S. 78-16 W. 70 feet to a stake at corner of Lot No. 5; thence with the line of said lot, S. 11-44 E. 164.3 feet to a stake; thence N. 39-03 E. 206.1 feet to a stake on Augusta Road; thence with the Western side of said Road, N. 5-23 W. 65 feet to a stake at corner of Lot No. 2; thence with the line of said Lot, N. 84-37 E. 150 feet to a stake; thence continuing with the lines of Lots Nos. 2 and 3, N. 7-51 W. 122.2 feet to the beginning corner.

Being the same property conveyed to Elizabeth E. Voyles by deed of James P. Moore and Otis P. Moore dated January 12, 1951, and recorded January 17, 1951, in Deed Book 427 at
