THE Grantor does hereby grant, bargain, sell and release unto the Grantee the right, privilege and easement to enter upon and exit from the property of the Grantor located at Hunters Ridge, located off Foot Hills Drive, in Greenville County, State of South Carolina, in and through said property of the Grantor as shown on the drawing entitled "Hunter's Ridge, a Limited Partnership to Commissioners of Public Works of the City of Greenville, S.C.", dated November 22, 1983, attached hereto and made a part hereof for the purpose of reading, operating, maintaining, replacing and adding to the water meters and other appurtenances thereto located on the property of the Grantor.

IT BEING understood that the water mains located in and serving Hunters Ridge and being on the property of the Grantor shall and do remain the property of the Grantor and the Grantor shall be fully responsible for the maintenance thereof.

And, the grantor does hereby bind itself and its successors to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same of any part thereof.
