KNOW ALL MEN BY THESE PRESENTS, that we, Jesse M. Ray, Jr., Frances Ray Clark and Mary Ray James, R.M.C.

in consideration of Twelve Thousand Five Hundred and no/100 (\$12,500.00) -----Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Charles Horace Loftis and Hazel E. Loftis, their heirs and assigns, forever:

All that piece, parcel or tract of land in Grove Township, Greenville County, State of South Carolina, and located on the south side of Reedy Fork Road (now named Ray Road) about one-half mile southwest of the Reedy Road Baptist Church, and being the western portion of Tract 3, Tract 3 being shown on a plat recorded at the Greenville County Court House, R.M.C. Office, in Plat Book T, page 466; that the property to be conveyed by this deed is further shown on a plat prepared by James R. Freeland, dated December 30, 1983, entitled "Property of Charles Horace Loftis and Hazel E. Loftis", showing the total acreage to be conveyed as 5.00 acres, and having according to the said Freeland plat the following courses and distances:

Beginning at a point in Ray Road, which is the joint corner of property owned by grantors and Craig W. and Barbara L. Valentik, thence S 31-43 E 951.48 feet to an old iron pin; thence S 76-30 W 291.00 feet to a new iron pin, being the joint property line of the grantors and Horace Loftis; thence along Young Road N 27-32 W 807.00 feet to a rail road spike in said Ray Road; thence along Ray Road N 42-10 E 175.90 feet to a rail road spike; thence along Ray Road N 50-16 E 49.01 feet to a rail road spike, which is the point of beginning.
