All that piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina, on the North side of E Street in Section #6 of Judson Mill Village, being known and designated as lot #18 as shown on plat of said Section #6 made by Dalton & Neves Engrs. Nov. 1941 and recorded in Plat Book K, at pages 106 and 107 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of E Street, joint front corner of Lots No. 17 and 18, running thence with the line of Lot No. 17, N. 1-37 W. 115 feet to an iron pin in the line of Lot No. 16; thence with the line of Lot No. 16, N. 88-23 E. 94.4 feet to an iron pin corner of Lot No. 19; thence with the line of Lot No. 19, S. 1-37 E. 163.8 feet to an iron pin on the East side of E Street; thence around the curve of E Street, N. 46-25 W. 69.3 feet to an iron pin on the North side of E Street; thence with the North side of E Street, S. 88-23 W. 45.2 feet to the beginning corner.
