that the lot shall receive general care as specified in Rule No. 5 on the reverse side hereof to which reference is
made.

warrant and forever defend the said premises to the said SAMUEL E. PAYNE, JR. AND JUDY S., THEIR *
heirs and assigns against itself and its successors, and against every person whomsoever lawfully claiming or to
claim the same or any part thereof; subject, however, to the restrictions and limitations herein contained.
