WHEREAS, Section 10-1(e) of the Greenville County Code allows provision of labor and equipment to perform maintenance on dedicated drainage easements; and,

WHEREAS, said Section requires formal dedication of easements, requests of all affected property owners and that all affected property owners hold Greenville County harmless in connection with said assistance; and,

WHEREAS, said easement dedication is permanent, and does not transfer ownership of property to Greenville County; and,

WHEREAS, said agreement to hold Greenville County harmless is only for work performed as provided by this agreement; and,

WHEREAS, the undersigned agrees to the above requirements and requests the assistance of Greenville County,
