All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in the Bates Township, about 12 1/2 miles north of the City of Greenville, on the mill road, leading from Buncombe road, and having according to a survey thereof made by W. A. Hester, Surveyor, July 5, 1939, the following metes and bounds, to Wit:

BEGINNING at a stake in the center of the said Mill road, eastern corner of the following described tract, and running thence N. 30 1/2 E. 26.15 chains to an iron pin, Thence S. 82 1/2 E. 9.33 chains to a cherry stump on the northeast bank of creek; thence N.
