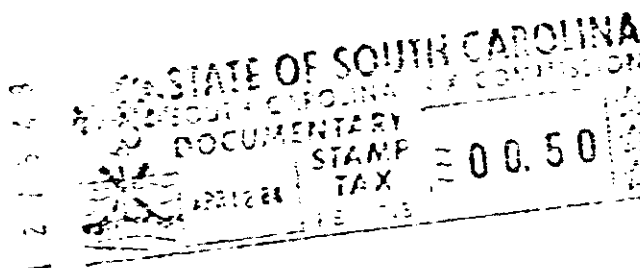
KNOW ALL MEN BY THESE PRESENTS that on this date 4 April 1984
