the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell  
and release unto J. T. WILSON, his heirs and assigns forever;

All of my remaining interest, including the life-estate reserved to me in  
a prior Deed in that certain tract or parcel of land,

That certain tract or parcel of land, with any improvements thereon,  
in Butler Township, said County and State, located about seven miles  
from Greenville and designated as Tract #4 on plat of the Walter Wilson  
Estate, prepared by H. S. Brockman, 11-13-51, and elineated thereon as  
follows:

BEGINNING at a stake in center of public road, joint corner of Tracts 2  
and 4, and runs thence with center of said road N. 25-35 W. one hundred  
and seven (107) feet to a point in road; thence still therewith N. 33-57  
W. one hundred and thirty-one (131) feet to a stake, joint corner lots  
4 and 5; thence S. 84-23 W. seven hundred and eighteen (718) feet to an  
iron pin, joint corner lots 4 and 5; thence S. 6-00 E. two hundred and  
eighty-six (286) feet to iron pin, cornering with Broadus Durant;  
thence N. 52-15 E. one hundred and ninety (190) feet to iron pin; thence  
S. 9-45 E. three hundred and thirty-two (332) feet to iron pin; thence  
N. 58-31 E. six hundred and ninety-nine (699) feet to the beginning  
corner. Bounded north by Tract #5, west by Frank Cox and Broadus Durant,
