WHEREAS, the undersigned are all property owners in a subdivision known as EDWARDS FOREST, SECTION II; and

WHEREAS, William M. Edwards did heretofore impose upon the numbered lots in said subdivision, certain restrictive covenants; and

NOW, THEREFORE, for and in consideration of the sum of One and No/100 (\$1.00) Dollar in hand paid to us we the undersigned owners of lots in Edwards Forest, Section II do hereby waive the requirements of paragraph 2 of the aforesaid restrictive covenants as they relate to lot numbers 80 and 81 and specifically approve the resubdivision of said lots as shown on that certain plat recorded in the RMC Office for Greenville County in Plat Book 9F at Page 63.
