Pipe; two (2) 6" Valves; four (4) 2" Valves; one (1) fire hydrant; and six (6) Valve Boxes as shown on a drawing entitled "Davis Properties to Commissioners of Public Works of the City of Greenville, S.C.", dated Jan. 10, 1984, attached hereto and made part of this conveyance.
