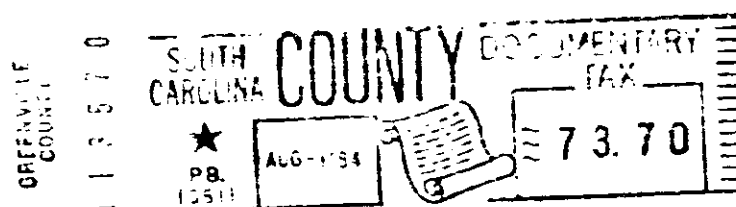
KNOW ALL MEN BY THESE PRESENTS, that WESTMINSTER COMPANY, INC.
