

SCHEDULE A

All my undivided interest in all that piece, parcel or tract of land containing 38 acres, more or less, lying on the southern side of Ansel School Road and the northeastern side of Memorial Drive Extension and the western side of proposed road known as Watson Road, in Chick Springs Township, Greenville County, South Carolina, being a portion of 537.4-1-44 in the Greenville County Tax Maps. This property is a portion of the same conveyed to the Grantor by deed of John J. McSwain, recorded on December 5, 1935 in the RMC Office for Greenville County, S. C. in Deed Book 181, page 521 and by deed of B. Lee Smith recorded in Deed Book 209, page 51 and by deed of E. Richard Taylor, Jr., appearing of record in Deed Book 666, page 223 recorded on January 11, 1961.

ALSO: All my undivided interest in Lot No. 3 and all of Lots Nos. 4, 8 and 9 of Property of E. R. Taylor on a plat made by Dalton & Neves Company, dated February, 1980, recorded in the RMC Office for Greenville County, S. C. in Plat Book 7-X, page 1, said lots being located on the western side of Taylor Road and being shown on the Greenville Tax Maps as portions of property resubdivided as T19-1-7 through 15, inclusive.

The above described property is a portion of the same conveyed to Grantor by deed of Lida F. Smith, recorded in the RMC Office for Greenville County, S. C. in Deed Book 487, page 85 on October 12, 1953.

ALSO: All that piece, parcel or tract of land, formerly containing 68.7 acres, more or less, situate, lying and being on the eastern and western sides of the Watson Road on the northern and southern sides of Ansel School Road and on the northeastern side of Memorial Drive Extension, shown on the Greenville County Tax Maps as 537.4-1-44, being all the property conveyed to E. R. Taylor by E. R. Taylor, Jr., described in Deed Book 666, page 223 recorded on January 11, 1961, less such parts thereof which have been conveyed to third parties prior to the date of this deed.

It is further the intention of the Grantor to convey by this deed any remaining property which may be owned by him on this date originally acquired by deed from John J. McSwain appearing of record in Deed Book 181, page 521 and by deed of B. Lee Smith, appearing of record in Deed Book 209, page 51, adjoining Ross, Kimbrell, Bridwell and others.

ALSO: All those pieces, parcels or lots of land being shown as Lot No. 63 and 65 on plat of Sections 1 and 2 of Belmont Heights Subdivision, made by Dalton & Neves, Engineers, dated July, 1960, recorded in the RMC Office for Greenville County, S. C. in Plat Book QQ, page 160 and 161 and also Lot No. 132 on a plat of Belmont Heights, Section 3, made by Terry T. Dill, Surveyor, recorded in the RMC Office for said county and state in Plat Book 4-F, page 29, which are shown on the Greenville County Tax Maps as T18.1-1-19 and T18.1-2-4 and 6. The above described property is a portion of the same conveyed to the Grantor by deed of Belmont Heights, Inc., recorded in the RMC Office for Greenville County, S. C. in Deed Book 959, page 74 on October 27, 1972.

ALSO: All those pieces, parcels or lots of land, situate, lying and being on the southwestern side of old U. S. Highway No. 29, near the intersection thereof with Gilreath Mill Road in Chicks Spring Township, Greenville County, South Carolina, being shown on the Greenville County Tax Maps as T16-2-11 and 46.1 containing 10 acres and 1 acre respectively and being more fully described in a deed from Nannie T. Moon to Thelma B. Taylor, recorded in the RMC Office for Greenville County, S. C. in Deed Book 171, page 234, recorded on February 21, 1935 and by deed of Burgiss Hills, a corporation to Thelma B. Taylor, recorded in the RMC Office for said county and state in Deed Book 432, page 75 on April 4, 1975 and devised to the Grantor under the Will of Thelma B. Taylor who died a resident of Greenville County, South Carolina in 1959, as will appear by reference to the records of the Probate Court for said county and state in Apartment 719, File 16.
