KNOW ALL MEN BY THESE PRESENTS, that Huff and Brewer Developers, a General Partnership

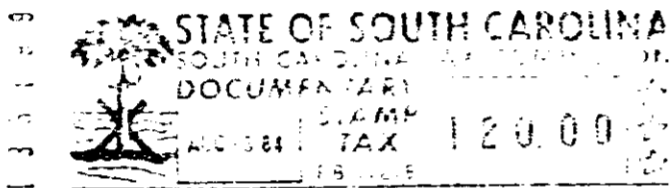
in consideration of Fifty-Nine Thousand Nine Hundred and No/100 (59,000.00) Dollars,
