

INTER-VIVOS OR "LIVING" REVOCABLE TRUST

We, Perry W. and Dorothy E. Shaffer of 411 Willow Springs Drive, Greenville, South Carolina, 29607, do herewith, this 13th day of January, 1984, establish an Inter-Vivos or "Living" Revocable Trust, naming the following Co-Trustees: Perry W. and Dorothy D. Shaffer, Co-Trustees, until the incapacity, death or demise of one or the other, upon which occasion the Survivor becomes Successor Trustee. In case of accident or for any other reason both of these Original Trustees die or are incapacitated, or upon the death of the First Successor Trustee of the Original Co-Trustees, then the following Co-Successor Trustees, Christine Shaffer-Casey of 311 Bennett Blvd., Chandler, Oklahoma, and James Donnelly of 425 Lancer Drive, Columbia, South Carolina, 29210, are to act together as Co-Successor Trustees to dispose of the estate or pertences of the Original Co-Trustees.

The Original Co-Trustees establish and shall maintain a comprehensive list of major items pertaining to the Estate, making any changes necessary as events dictate, keeping the list up-to-date so that Successor Trustees will be adequately guided with instructions as to final disposition of the items. This Trust may be revoked at any time, by acknowledged instrument in writing, either by the two Original Co-Trustees during their lifetime, or by either of them after becoming a Successor Trustee, but upon the death of the last of the two Original Co-Trustees, this Trust shall become Irrevocable--The Successor Co-Trustees agreeing to dispose of the items listed in Schedule A with any Amendments dictated by changes that have occurred in the items listed, and any other items found pertaining to the estate, and in accordance with the instructions given therewith for their disposal.
