

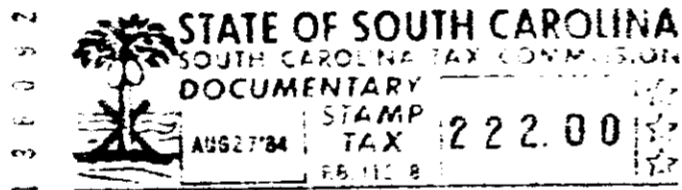
KNOW ALL MEN BY THESE PRESENTS, that U. S. Retirement Corporation
