in consideration of Eight Thousand and 00/100 (\$8,000.00) Dollars,

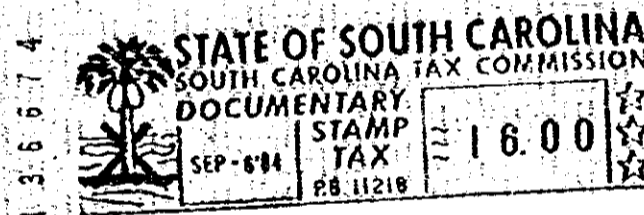
