BEGINNING at a point on Sterling Street 50 feet north of the southwest corner of Maloy and Sterling Streets and running thence along Sterling Street N 23-10 W., 43 feet to an iron pin; thence S 66-45 W., 158 feet to an iron pin; thence S 23-30 E., 43 feet to an iron pin; thence N 66-45 E., 157.9 feet to the beginning corner.
