Page 62 and having, according to said recorded plat, metes and bounds as shown thereon.

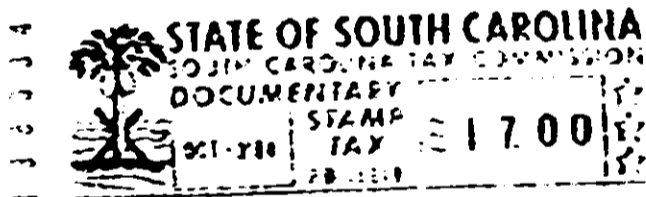
This conveyance is made subject to all restrictions, easements, rights of way, setback lines
