the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Mariah Benson

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in city of Greenville, being shown and designated as lot number six (No. 6) in section "B" on a plat of the "Glenn Farms" subdivision, surveyed by H. S. Brockman, Sur., August 1943, said plat recorded in plat Book "M" at page 75 in the R. M. C. office, and, by a recent survey and plat made by O. C. Jones, C. E., August 22, 1964, having the following notes and bounds, to-wit:
