to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto

H. G. PROFFITT, Inc., its successors and assigns, forever, the following described property:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northwesterly side of East Shallowstone Road, near the City of Greenville, South Carolina, being known and designated as Lot 672 on plat entitled "Map 2, Section 3, Sugar Creek" as recorded in the RMC Office for Greenville County in Plat Book 9-W, Page 63, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of East Shallowstone Road at the joint front corner of Lots 672 and 673, and running thence with the common line of said Lots N. 32-28 W., 150 feet to an iron pin, joint rear corner of said Lots; thence S. 57-32 W., 100 feet to an iron pin, joint rear corner of Lots 672 and 671, thence turning and running with the common line of said Lots S. 32-28 E., 150 feet to an iron pin, joint front corner of Lots 672 and 671 on the northwesterly side of East Shallowstone Road; thence with the northwesterly side of East Shallowstone Road, N. 57-32 E., 100 feet to an iron pin, the point of beginning.

This property is conveyed subject to all restrictions, setback lines, roadways, easements, and right-of-way, if any, appearing of record, on the premises or on the recorded plat, which affect the property hereinabove described, including 25' sanitary sewer easement as shown on recorded plat.
