It is distinctly understood that said lot is to be used exclusively for the burial of human bodies and is sold and conveyed subject to all rules and regulations printed on the back hereof and any additions or amendments for the government of the Cemetery which may hereafter be adopted.

TO HAVE AND TO HOLD the above granted property to the said Alton Dean ***

heirs and assigns, forever; subject, however, to the restrictions and limitations above referred to.

And GRACELAND CEMETERY DEVELOPMENT CO., INC., for itself, and successors and assigns, covenants with the said Alton Dean *** that the lot shall receive general care as specified in Rule No. 5 on the reverse side hereof to which reference is made.

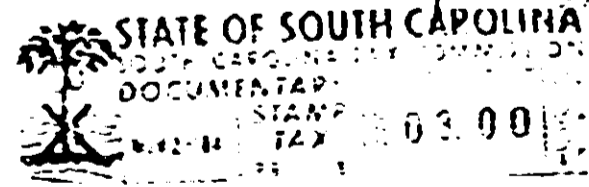
