Office for Greenville County. Said Arthur Kaswell died as a resident of Greenville County on March 23, 1980, leaving a Will whereby he devised his real estate to his wife Marion B. Kaswell, however, a Judgment of Divorce Decree was entered between Marion B. Kaswell and Arthur Kaswell dated October 11, 1974. Since a legal question arose as to whether or not a decedent could leave property to his divorced wife under South Carolina law, James Kvasnicka, the sole heir-at-law of Arthur Kaswell executed a quit claim deed in
