John H. Hendrix, Sr. died intestate November 10, 1964 survived by his sole heirs at law, his wife, Lillian H. Hendrix, and children, Martha L. Hendrix, Elisha Barnwell Hendrix and John Henry Hendrix, Jr., as will appear by reference to Apartment No. 887, File No. 15 in the Probate Court for Greenville County, South Carolina. Lillian L. Hendrix died intestate July 24, 1977 survived by the same aforesaid children as will appear by reference to Apartment No. 1478, File 22 in the Probate Court. The Grantor herein is one of the children of John H. Hendrix, Sr. and Lillian L. Hendrix.
